


ROCK, SCISSORS, PAPER STREETS Judy Mathiau, CMA, Winslow Assessor

How often have we heard the term "paper streets" and wondered what we are supposed to do with them?

A paper street is an undeveloped and unaccepted proposed way laid out on a subdivision plan that was recorded at the registry of deeds. They are a potential dedication to the public, where the town may accept as a public street at a later date.

These roads - see image - float on the surface of a paper tax map, with no purpose really and while we as assessors do not necessarily have to address them (no pun intended), it is good to at least understand the basics of the



1987 law and become familiar with any paper streets in your town.

Your municipality may have already adopted an ordinance or a policy that details an action plan for paper streets in response to the new law enacted in September 1987. The law is complex and one should read the statutes thoroughly. Title 23, Sections 3031, 3032 and Title 33 Sections 460-469-A.

If the subdivision was recorded before September 29, 1987 and there are paper streets still present on September 29, 1997 or 15 years after the recording, whichever is later, then those streets are deemed vacated (public and private rights are terminated.)

<u>UNLESS!</u> Unless the municipality officially extended the "deemed vacation" for an additional 20 years. If the town did grant a 20 year extension to September of 2017 and the "paper street" is still not developed or accepted by the town as of the extended date, then again, it would be deemed vacated; <u>UNLESS!</u> Unless the town grants yet another 20 year extension.

If the subdivision was recorded on or after September 29, 1987, any existing paper streets would be deemed vacated 20 years from the recording. Period.

Although the law deems vacated streets to be owned by the abutter to the center line, they still have the burden of proof to establish title. So what should the assessor do?

I would not recommend suddenly dividing vacated paper streets amongst abutting landowners! They must document claim to their divided interest. In Winslow, a deed was recorded in 2013 from a couple to themselves on a piece of land they own, and included in the new deed, was the description of a vacated street and their claim to a divided $\frac{1}{2}$ interest in title citing the statute mentioned above.

I have begun researching every subdivision and every proposed, accepted, constructed or vacated street in Winslow. Become familiar with your subdivisions and take inventory of all streets including any undeveloped portions. Check your town for any policies or plans already created.

The Maine Townsman has published articles on paper streets, including two by former MMA Staff Attorney Joe Wathen in 1996 and another in November 2013 written by Dale McGarrigle.

TAX NOTICE......Notes and News from the Property Tax Division

A **CMA exam** was administered on November 9th. Congratulations to six new assessors! The next exam is scheduled for Wednesday, February 8, 2017. The registration form is available on the Property Tax website: **www.maine.gov/revenue/propertytax/**.

MRS Rule 205 Amendment - Certification of Assessors - was officially adopted in November. The division is currently drafting the applicable forms and a new bulletin to further describe the advanced certification and renewal process.

The 2nd annual **Maine Property Tax Institute** is scheduled for May 10 - 12th and will return to Sunday River Ski Resort in Bethel. An entertaining agenda is planned with the intent of qualifying for advanced assessor training. The 70th annual **Maine Property Tax School** will return to Belfast for the week of July 31—August 4, 2017. Jeff Kendall is in negotiations to provide a week-long IAAO course at Tax School, which will also qualify for advanced assessor training.

The **Property Tax Course** PT101 is in the final stages of review and an updated textbook version is expected to be available in the next few weeks. The current changes are the result of feedback from students and instructors from last year's Tax School. Next up for review is PT102. Both the PT101 and PT102 texts are available on the Property Tax website and the updates will be posted as soon as they are available. PT103 is in the preliminary stages of a full rewrite and should be ready for its debut at the 2017 Tax School.

An assessor peeking into the windows of a dwelling while conducting an appraisal was considered "permissible conduct" by a Louisiana Tax Court. The taxpayer had consented to the appraiser's visit but later claimed that the appraiser violated the homeowner's Fourth Amendment Rights.

That decision followed another ruling which involved an appraiser entering a posted property without consent of the owner, but never looked into or entered the house—in this case the entry did not constitute an un-



conditional search because the appraiser entered the property for the administrative purpose of a tax assessment.
