ME CHAPTER AND MAINE REVENUE COLLABORATE ON PROPERTY TAX SCHOOL IAAO COURSE

s we are all aware, there are three approaches to value: cost, income and sales. Most of our work involves using the cost and sales approaches. Municipalities with malls and other high-value commercial properties use the income approach regularly. For the rest of us, the approach is more concept than it is a working tool and, as a result, our ability to understand and use the tool is limited.

With this in mind, the Maine Chapter and Maine Revenue Services has collaborated on

bringing the IAAOsanctioned Course 102: The Income Approach to Valuation to this year's Property Tax School curriculum.

Course 102: The Income Approach to Valuation is designed to provide students with an understanding and working knowledge of the procedures and techniques required to estimate the market value of vacant or improved properties by

the income approach.

The material covers real estate finance and investment, capitalization methods and techniques, analysis of income and expenses to estimate operating income, selection of capitalization rates, and application of the approach. The Income Approach to Valuation utilizes lectures, classroom discussion, and homework problems to emphasize the main concepts

and procedures taught in the course.

IAAO courses and workshops are developed under the guidance of the IAAO Education Subcommittee as part of a curriculum on appraisal procedures and assessment administration offered throughout the world.

All IAAO courses offer 30 hours of course instruction plus a final exam. Maine Revenue Services is offering 33.5 continuing education credits for attendees who take the course and exam, and 30 credits for those who take the course without the exam.

Students who have successfully completed a course will receive a Certificate of Completion. Students who don't pass, or don't take the exam, will re-

ceive a Certificate of Attendance.

The exam is optional. People who don't pass the test will receive an application for reexamination along with their examination report.

The course will be taught by St. Cloud, Minnesota assessor, Stephen C. Behrenbrinker, CAE. Mr. Behrenbrinker is a IAAO Approved Senior Instructor.

As with all IAAO and Appraisal courses offered at Property Tax School, there are additional fees to cover course materials and instructors' fees. To that end, the Maine Chapter is offering two scholarships to qualifying members. See page 2 for details.

MICHAEL L. AUSTIN SCHOLARSHIPS AVAILABLE FOR INCOME APPROACH COURSE AT NEXT MONTH'S TAX SCHOOL

he Michael Austin Memorial Scholarship is awarded annually to a CMA looking for financial help with courses provided by IAAO, MRS Property Tax School, or other courses related to assessing, including online courses. The scholarship covers only the cost of a course; it does not cover costs associated with travel.

This year the Maine Chapter will be awarding two Michael Austin scholarships for members taking IAAO Course 102: Income Approach to Valuation.

The scholarships cover the cost of the course (\$275) plus full-week tuition to Property Tax School (\$175). Scholarship recipients are responsible for their own food, travel and lodging expenses. (Property Tax School full-week tuition does however include lunch all week and the Monday night lobster bake.)

alded to IAAO staff by the following internal memo to staff:


"Yesterday, Matt Sturgis,
