SECRETARY'S REPORT: Judy moved to accept the 9/16/16 minutes as written, seconded by Martine, all in favor as motion passes unanimously.

TREASURER'S REPORT: Matt reports savings account has a balance of \$8,610 and checking has \$4,149.22. An outstanding check has been written to Ramada Seasons for \$175 securing the November meeting space.
