

It occurred to all of us in the room that we were dealing with the same problems within our own corner of the municipal world. Financial constrictions and the challenge of replacing older workers as they retire.

# PROPERTY TAX INSTITUTE May 16-18 Sunday River

### Maine News

**Doreen French** was awarded the revaluation contract for the town of Roques Bluff. Congrats!

In **Westport Island**, the selectmen/assessors denied an abatement request because the owner had an appraisal done and later agreed that the comparables were not qualified sales.

The **Sunday River Golf Course** plans to appeal to the SBPTR after being denied their abatement request in Newry. The initial assessment of \$4.72 million was reduced to to \$3.36 million, but the owners requested \$2.55 million.

Brenda Cummings, **Bath** Assessor has announced her release of an RFP for revaluation services. She will share her RFP for anyone interested. She has also created a proactive web site for the taxpayers.

In the coastal town of **Thomaston**, a request was made by Walmart to reduce their big box value from \$15 million to \$7 million, but was rejected by the assessors based on an incomplete application. The assessors plan to request further information with a 30 day deadline.

Similarly, **Bangor Mall LLC** did request the valuation reduction from \$60.9 million to \$28.9 million based on a single economic unit. Assessor Philip Drew has requested additional information with a 30 day deadline.

In **Chicago**, the Cook County Assessor came under fire for the overvaluation of a select number of homes which absorbed more than 2 billion in tax shifts.

A well known Maine attorney, **Joel Moser** of *Bernstein Shur*, was appointed to the IAAO Task Force on Contracting for Assessment Purposes. He will use his experience from working with Maine assessors in order to add value to the IAAO team and to municipalities around the country.

**President Trump** sued Palm Beach County for property taxes assessed to a golf course. An appraisal resulted in a value of \$19 million and President Trump argues that it has a value of \$50 million?

Nearly half of employees in the assessment industry plan to retire or leave in the next nine years, according to the new IAAO compensation survey.

The IAAO on line site linked the story from the *Bangor Daily News* about a group of taxpayers in the town of York forming the **Solar Owners of York Association.**



## Notes and News from the Property Tax Division

The month of May brings with it signs of spring and the annual migration of assessors to the mountain. Sunday River Ski Resort will be the home of the third annual Maine Property Tax Institute, co-sponsored by the Maine Chapter IAAO and the Property Tax Division. This year, the Property Tax Institute, will offer IAAO Workshop 155 - Depreciation Analysis, presented by IAAO Senior National Instructor David Cornell. For more information and to register, go to the Property Tax Website: www.maine.gov/revenue/ propertytax/.

The Property Tax Division administered a CMA exam on February 7. Of the 5 candidates sitting for the eight-hour exam, 3 passed. Congratulations to the first new Certified Maine Assessors for 2018! The next exams are scheduled for Wednesday, May 9 and Friday, August 3. The registration form for the next exam is available on the Property Tax website: www.maine.gov/revenue/propertytax/.

Several Property Tax bulletins have been updated and reposted to the website:

Bulletin No. 10 - Property Tax Abatement and Appeals Procedures. The primary change was the addition of a flowchart showing the standard residential abatement/appeal process that will help taxpayers understand the steps in the process.

Bulletin No. 22 - Training and Certification. This bulletin was updated to clarify the process of becoming an assessor and retaining certification.

Bulletin No. 26 - Advanced Assessor Training and Certification. Due to the evolving nature of the advanced assessor certification program, the bulletin was updated to clarify the process of advanced assessor certification. As a supplement to the bulletin, a list of currently approved advanced assessor training courses was also posted.

The Property Tax Division has lost another family member to retirement. Mike Rogers retired at the end of March, after more than 41 years of state service. Mike was an indispensable source of property tax knowledge and leaves some large shoes to fill.
