

Have you ever read the Dunham Report? If you have not, it's a must read. I have been attempting to research the creation of Maine "assessors" and in doing so, I remembered a document passed on to me by David Ledew.

Pursuant to a joint order of the 102nd legislature in 1968, a study was conducted by the University of Maine's Bureau of Public Administration. The report was titled **A STUDY OF PROP-ERTY TAX ADMINISTRATION IN THE STATE OF MAINE**, written by Paul Dunham, (Institutional Research at UM) in 1969. The state recognized the need for improvements "not to the property tax, but to the administration of the assessment process".

The working group met with the Bureau of Taxation during the 1968 annual Property Tax Conference, where the following was acknowledged:

- \* Most important Maine tax
- \* Too little state supervision
- \* Insufficient staffing and financing
- \* Lack of coordination of resources
- \* Appeals process is discriminatory
- \* Adequate data not available to the public
- \* No training and certification available
- \* Lack of qualified assessors
- \* Need to modernize local government

Primary attention was directed at the need for training and continuing education. They felt that a lack of training equaled a lack of assessment quality. Continued on page 2.....

In **Rockland**, assessor Roxy LaFrance has agreed to stop taxing the personal property associated with short term rental operations and apartments with less than 4 units.

With the rise in municipal tax rates, several towns are opting for local tax relief programs. In **Brunswick**, they are considering tax relief for their senior citizens. In **Winslow**, the council opted to include an insert with the tax billing, explaining tax relief programs already in existence. And in **Rockport**, they included an insert with information as to the increase in school budgets and the decrease in state subsidies.

The 1969 report states several ideas for training in the field of real estate law, admin, appraisal, knowledge of government structure, building construction, surveying and public relations.

Another recommendation was to create certification of assessors. ...only those who are found to be competent in property tax matters should determine assessments...

Research showed that of the 1500 assessors statewide, most were elected selectmen who later found out that they were also assessors. However, 10 local assessors actually held a CAE (Certified Assessment Evaluator) from IAAO!

The group recommended three levels of certification based on education and experience. 1) probationary, 2) provisional and 3) certified assessor.

The study further concluded that the appeals process was discriminatory. ... the appeals process favors the well to do and the not the ordinary man on the street... It was recommended to establish guidelines for the steps involved and to create a state tax court.

The report also included a list of the report's study group which included Norman Ledew, then director of Property Tax (David's father) and Norman Gosline, a local commercial appraiser.

I wanted to point out Kerry's favorite recommendation from the report.

A minimum of 1% of the revenue generated by the property tax be deducted from the proceeds and used for administration


# IAAO NEWS

#### OPEGA

Phillip Drew, Bangor Assessor

The Office of Program Evaluation & Government Accountability (OPEGA) in the Maine State Legislature is currently conducting a review of the Business Equipment Tax Exemption (BETE) and Business Equipment Tax Reimbursement (BETR) programs.

The team is currently visiting assessing offices to interview those that administer these programs at the municipal level. David Ledew mentioned this review to me some time ago, following the City of Bangor's legislative testimony on BETR/BETE.

OPEGA is interested in management's (Finance and Manager) opinions, as well. If they visit your office, they will speak with you to understand your community's involvement in these programs and how these programs impact the community both positively and not-so positively.

Following my interview, I spent more time on their question regarding compliance cost. The true administrative cost includes the time to: receive, process, educate (the taxpayer or tax-payer's agent), complete forms, review and prepare proper notifications, especially for non-qualifying assets under the BETR program. In my opinion, the OPEGA staff is seeking to develop a true picture of these programs and our feedback is critical whether we are: assessors (full-time, part-time), assessor's agents or selectperson assessors.

Our participation will allow OPEGA to develop a complete report which will then be used to inform the Maine State Legislature.

# Tax Notice

#### Notes and News from the Property Tax Division

The 71<sup>st</sup> Maine Property Tax School ended on Friday, August 3. This year's Tax School generated valuable feedback and suggestions for future speakers and topics from the nearly 250 attendees. Planning for next year's Tax School is underway.

The Property Tax Division administered a CMA exam on August 3. Of the 24 candidates sitting for the eight-hour exam, six passed. Congratulations to the new Certified Maine Assessors! The next exam is scheduled for Wednesday, November 7, and will be held in Augusta at the Property Tax Division office. The registration form for the exam is available on the Property Tax website at: https://www.maine.gov/revenue/propertytax/.

The Property Tax Division is hosting IAAO Course 101 - Fundamentals of Real Property Appraisal - in Portland during the week of October 29. More than 20 people have signed up for this week-long course, a key ingredient for achieving advanced assessor certification. The interest shown in this course will have a positive impact on the division hosting another IAAO course next year. The goal is for an IAAO course offering to be an annual event, in addition to the Maine Property Tax Institute in the spring and the Maine Property Tax School in the summer.

Now that the Legislature has finally adjourned for the year, the Property Tax Division has written a summary of enacted legislation affecting property taxes. You can find this summary on the Property Tax Division website.

A task force to suggest improvements to the State Board of Property Tax Review has been established by law this year. This task force should be meeting soon. Watch the Property Tax website for more information and the opportunity to make suggestions.
