The Maine Real Estate Association reported a 3% increase in sales and a 9.5% increase in sale price during November 2018 compared to 1 year ago.

Clinton seeks approval of a town wide revaluation, using funds from the town's undesignated fund balance. The recommendation comes from their contracted assessor's agent, Garnett Robinson.

**Justin Hennessey** has returned as assessor to Topsham, leaving Brunswick after a short stay.

And in Brunswick, a few residential taxpayers are appealing their **solar panels** to the court, even after to the town reduced the per panel value to \$200.

Judy Mathiau was appointed to the IAAO *Rural Education Task Force*. Chapter members will be updated on the progress.

#### IAAO Conference 2022 set for Boston!

The MAAO, the Property Tax Division and the Maine Chapter IAAO all sent in written correspondence to support the request made by Lane Partridge, president of the Massachusetts IAAO Chapter, who rallied the New England assessors in support of the location.

In Middlesex TWP, PA, 2 county assessors were conducting an on site inspection. After knocking on the door and ringing the bell, with no response, they went to the back of the house to measure a deck. The owner then appeared behind them with a rifle. Nobody was injured.

**Airbnb** is also creating issues outside of Maine. In Palm Beach County, FL, county commissioners voted a new law to require registration of the units and to collect a tourist tax. The company has already been paying a sales tax to Florida and reported more than \$45.7 million in tax revenue during 2017.

In a recent IAAO thread, a fellow assessor asked about **developer's discounts.** An Idaho assessor responded that their state gives a 75% market value exemption on the land owned by a developer, if the developer has built its infrastructure.

A taxpayer was forced to return \$330,000 in property tax to the county, based on a charge of fraud.



Apparently, the taxpayer removed his **5 toilets** so it could be reassessed as uninhabitable and at a lower value, thus obtaining money by means of false representation.

In New Orleans, a developer who is building a 1200 room high rise hotel hopes to receive a property tax exemption, once he assigns the ownership to a non-profit. However, the assessor is determined that even though it will be a **non-profit**, they will not be entitled to a tax break as a commercial entity. He expects that the developers will file a law suit.

### Notes and News from the Property Tax Division

2019 brings with it a new governor and a new Legislature. This year's legislative session is looking like it will be a busy one, with property tax relief one of the significant topics currently being discussed. The Property Tax Division will be monitoring this year's session and providing information to the Taxation Committee when requested. You can follow the bills being considered this session from the Legislature's website at legislature.maine.gov and Maine Municipal Association's weekly Legislative Bulletin, which is published every Friday during the session and is sent to municipal officials.

The Property Tax Division hosted a Certified Maine Assessor exam on Wednesday, November 7. Six candidates sat for the exam and four passed. This brings the total to 14 new CMAs for 2018. Congratulations to all the new assessors! For those of you who know someone interested in becoming an assessor or if you yourself get the urge to sit for the eight-hour test, the next exam will be Wednesday, February 6, in Augusta.

IAAO Course 101 - Fundamentals of Real Property Appraisal was held in Portland during the week of October 29 through November 2. The class was a success and elicited some very positive feedback. The Property Tax Division will be offering another IAAO course in Portland next fall. The October 21 - 25 class is tentatively scheduled to be Course 300 - Fundamentals of Mass Appraisal.

The 2019 education calendar is now available on the Property Tax Division website at maine.gov/revenue/propertytax/trainingcertification/courses.htm. The calendar will be expanded as more events are scheduled, but there is already a full slate of continuing education offerings for the new year.
