#### Chapter President Judy Mathiau

Hope this newsletter finds you all well and healthy! Happy Spring and cheers for warmer weather.

I am sure we have all been working on projects this past winter—would love to hear from you on what you have been working on, what's new?

I have been busy creating a quarterly review system in order to begin reviewing all residential properties. The town of Winslow had a professional town wide revaluation in 2008 and I started working here in 2010. To date, the overall assessments have held within a few points of 100% and the quality rating has never increased over 10. However, with so much time in between on site visits, I felt it was time to inventory properties.

For those who know me, I am an organize freak, and before I attempt any project I want to make sure the process is well planned and that a system is in place from beginning to end.

A few months ago I reached out to the assessors on the MAAO list serv to ask for advice on strategizing this project. I received very helpful information from a few who have done this before. My takeaways include:

In Auburn, they have an ongoing quarterly cycle, which they track in their CAMA system. They include inspections that were made due to new construction, often accompanying the code officer on site visits.

In Bucksport, the assessor mails a postcard to the taxpayers indicating their intent to inspect the property within the next 3 weeks.

A reval firm who contracts with several towns indicated that they begin the quarterly review 3-4 years out from a town wide reval. A typical site review for them is a quick observance of the

Marian Anderson, has recently been hired as town manager in Houlton, leaving Wiscasset after 5 years.

In **Oakland**, a taxpayer was granted an abatement going back five years. Once the assessor was able to gain access and correct the value and issue an abatement for year 1, the council refunded for 4 more.

Congrats to **Tom Walker**, formerly employed by MRS, has joined the municipal workforce as the assessors' agent in New Sharon.

The town of **Clinton** shot down a request to finance a professional revaluation, and now the town officials are looking at other options.

Tyler Technologies will conduct **Portland's** first revaluation in 13 years. Properties will be visited over the next year with final implementation for fiscal year 2021.

**Bob Tripp** is now working for the town of Alfred.

### The Lighter Side of an Executive Board Member


Meet Darryl McKenney, Waldoboro Assessor et al

# Tax Notice

#### Notes and News from the Property Tax Division

The First Regular session of the 129<sup>th</sup> Legislature is about halfway through and tax reform is clearly on the agenda. As of this writing, the Revisor's Office has printed just over 1,200 of the 2,000 bills proposed this year. Of that 1,200, Maine Revenue Services is tracking 187 bills and the Property Tax Division is following 54. At this rate, there is the potential for 90 property tax bills, which would be much higher than usual, even during a long session.

You can follow the bills being considered this session from the Legislature's website at legislature.maine.gov and Maine Municipal Association's weekly Legislative Bulletin, which is published every Friday during the session and is sent to municipal officials.

The Property Tax Division hosted a Certified Maine Assessor exam on Wednesday, February 6. One solitary candidate sat for the exam. While that candidate performed well for a first-timer, we are still looking for the first CMA of 2019. The next exam will be Thursday, May 16, in Augusta.

Jeff Kendall and others in the Property Tax Division are working on this year's educational events. The Property Tax Institute will be held May 8 - 10, and the registration form should be available soon, if it hasn't already been posted by the date of this publication. Preparations for Property Tax School are well under way; speakers and topics are being scheduled for the August gathering in Belfast. And don't forget to mark your calendars for the week of October 7 – 11, when the division will host IAAO Course 300 – Fundamentals of Mass Appraisal – in Portland.
