

## State Property Tax Deferral Program

loan program that can cover the annual property tax bills of Maine people who are ages 65 and older or are permanently disabled and who cannot afford to pay them on their own. The loan program allows Maine's most vulnerable community members to age in place and ensures that property taxes are still delivered to municipalities, requiring repayment of the loan once the property is sold or becomes part of an estate.

The application period for this program is January 1 through April 1. The 2022 filing period is over. The 2023 form will be posted on January 1, 2023.

#### LD 290 - An Act to Stabilize Property Taxes for Individuals 65 Years of Age or Older Who Own a Homestead for at Least 10 Years

Reminder - this bill was enacted and information/applications are yet to be disseminated from Maine Revenue Services
